1. READ THIS

The rendition filing date is April 15th. Section 22.28 of the Texas Property Tax Code requires the chief appraiser to impose a 10% penalty on businesses that fail to timely render their tangible business personal property used for production of income. The deadline for filing business personal property rendition will be extended to May 15th if a business owner files a written request no later than April 15th. If the initial 30-day extension is timely requested, the chief appraiser may further extend the deadline an additional 15 days to May 30th if requested in writing and if good cause is shown. **Please note that request for extensions must be submitted by the business owner, the business owner's authorized agent who has a designation form on file with the Gonzales Central Appraisal District, or the owner's attorney. Extension requests submitted by unauthorized agents will not be approved.**
