

**MINUTES
BOARD OF DIRECTORS
GONZALES CENTRAL APPRAISAL DISTRICT
NOVEMBER 18, 2025**

The Board of Directors of the Gonzales Central Appraisal District met on Tuesday, November 18, 2025 at the appraisal district office located at 301 N. Saint Joseph Street, Suite A, Gonzales, Texas. Board members present were Sue Gottwald, Bud Box, Josh Gray and D'Anna Robinson. Also, present were John Liford, Chief Appraiser; Nick Rapoza, Deputy Chief Appraiser and Lisa Pakebusch, Recording Secretary.

Sue Gottwald, Chairman, declared a quorum and called the meeting to order at 5:30 pm.

The minutes of the October 21, 2025 board meeting were reviewed by the Board. A correction was made on the time from 5:00 to 5:30 pm. Upon motion by D'Anna Robinson, Bud Box seconded and the motion passed by unanimous vote.

The Board reviewed the financial report for the month of October 2025. Mr. Liford reported the budget categories that were over the monthly average and stated the district was under budget for the month of October by \$82,465.64 and under budget year to date by \$473,641.39. Josh Gray motioned to approve the financial report as presented. The motion was seconded by D'Anna Robinson and passed by unanimous vote.

Josh Gray, secretary, reported that all checks presented have been signed.

There were no Public Comments.

Following discussion, Josh Gray motioned to raise the check amount from \$3,500.00 to \$5,000.00 for one signature. The motion was seconded by Bud Box and passed by unanimous vote.

Sue Gottwald, Chairman, opened the only bid received for Employee Health/Life & AD&D Insurance from Linda Carter with Texas Benefit Solutions, Inc. Following discussion, D'Anna Robinson motioned to award Texas Benefits Solutions, Inc. the one-year contract for Employee Health/Life & AD&D Insurance beginning January 1, 2026. The motion was seconded by Josh Gray and passed by unanimous vote.

The Board adopted Resolution No. 417, appointing Rusty J. Clampit, DVM to serve as a member of the Agricultural Appraisal Advisory Board for the term beginning January 1, 2027 and ending December 31, 2028. Upon motion by Bud Box, D'Anna Robinson seconded and the motion passed by unanimous vote.

Mr. Liford reported that 6 attended the Rural Chief Appraiser conference and the RPA's received 8 hours of continuing education. He also reported that one employee attended an exemption class last week and one will be attending a Deed class later this week.


Mr. Liford reported that the District is processing Homestead applications and the appraisers are working out in the field.

Mr. Liford also reported that the District has received Resolutions from 5 Entities for the upcoming BOD Elections for 2026-2027.


As for the land/new building update we are still waiting on the Head Mason to approve the sale of the two acres to the District.
